Sweepstakes Official Rules

VOID WHERE PROHIBITED OR RESTRICTED BY LAW OR REGULATION.

BY ENTERING THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH FORM A CONTRACT. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITY OBLIGATIONS ON THE PART OF ENTRANT AND A LIMITATION OF ENTRANT'S RIGHTS AND REMEDIES.

1. ELIGIBILITY: This Sweepstakes is open to legal residents of the 50 United States who reside in one of the following states: **CT, ME, NJ, NH, NY, MA, PA, RI or VT**, who are twenty-one (21) years of age or older, whose residence is located within a 45-mile radius of a Harvey Building Products warehouse, showroom or manufacturing location (collectively a "**Branch**") at the time of entry (the "**Entrant**"). Persons in any of the following categories are NOT eligible to participate or win a prize: Employees, officers, directors and agents of Sponsor, Administrator, and each of their affiliated companies, subsidiaries, licensees, franchisees, distributors, dealers, sales representatives, their advertising and Sweepstakes agencies, and any and all other companies associated with the Sweepstakes (collectively, the "**Sweepstakes Entities**") and each of their immediate family of any person in any of the preceding categories (including mother, father, sister, brother, daughter, son, spouse, grandmother, grandfather, children or grandchildren), regardless of where they live; or persons who reside in the same household, whether related or not, as any person in any of the preceding categories. "Household members" shall mean people who share the same residence at least three months a year, whether related or not. One (1) potential winner will be randomly selected for each local Branch Sweepstakes (thirty-six (36) in all) by the Sponsor, from all eligible entries received in each specific Branch during the Sweepstakes Period, on or about Tuesday, October 4, 2019. The Grand Prize drawings will be conducted on or about Monday, October 14, 2019. Only the thirty-six (36) winners of the local Harvey Building Products local Branch drawings will be included in the Grand Prize drawing.

Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Harvey Building Products, 1400 Main Street, Waltham, MA 02451 (the "**Sponsor**") and/or Cohen-Friedberg Associates, LLC, Framingham, MA 01702 www.cfapromo.com (the "**Administrator**") whose

decisions shall be final and legally binding in all respects and not subject to further review in any forum.

3. HOW TO ENTER:

- For each \$300 you spend at a local Branch on Harvey Building Products roofing, siding or windows, you will receive one (1) entry into that Branch's Sweepstakes. **LIMIT:** not to exceed twenty (20) entries per customer.
- At the end of the Sweepstakes Period, each Branch will randomly select one (1) entry to receive a Holy Stone HS700 GPS Drone ("**Branch Drawing**"). Each Branch Drawing winner will receive one (1) entry into the Grand Prize drawings.

You may enter without a purchase by sending a sending a 3"X5" card in a #10 standard envelope, containing your first name, last name, company name, address, city, state, zip, telephone number, and the local address of the nearest Harvey Building Products Branch to: Harvey Building Products Promotions Department, 1400 Main St, Waltham MA 02451. Mail-in entries must be received inside of the Sweepstakes period. Sponsor is not responsible for lost, late, damaged, incomplete or postage due mail.

Entry Notes: Any attempted form of entry other than as described herein is void. Sponsor will determine in its sole discretion, what constitutes a valid entry and reserves the right to reject any submissions that it deems, in its sole discretion, to violate any of Sponsor's policies, standards, or practices.

Sponsor reserves the right to cancel or modify the Sweepstakes if fraud or technical failures impair the integrity of the Sweepstakes as determined by the Sponsor, in its sole discretion, and to award the Prize based on eligible entries received prior to the cancellation.

Entry Notes: Entries made on another's behalf by any individuals or other entities will be declared invalid and disqualified for this Sweepstakes. Tampering with the entry process or the operation of the Sweepstakes is prohibited, and any entries deemed by Sponsor, in its sole discretion, to have been submitted in this manner will be void. ARV of this prize package is \$4,950

- Five (5) nights (inside cabin) accommodations.

ARV of this prize package is \$5,500.
