

Harvey Building Products Polaris® Switchback® Pro-S Sweepstakes

Official Rules

VOID WHERE PROHIBITED OR RESTRICTED BY LAW OR REGULATION.

BY ENTERING THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH FORM A CONTRACT. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITY OBLIGATIONS ON THE PART OF ENTRANT AND A LIMITATION OF ENTRANT'S RIGHTS AND REMEDIES.

1. ELIGIBILITY: This Sweepstakes is open to legal residents of the 50 United States who own their primary single-family home in one of the following states: **CT, ME, NJ, NH, NY, MA, PA, RI or VT**, who are twenty-one (21) years of age or older, whose primary single-family residence is located within a 45-mile radius of a Harvey Building Products warehouse, showroom or manufacturing location (collectively a "**Branch**") at the time of entry (the "**Entrant**"). Persons in any of the following categories are NOT eligible to participate or win a prize: Employees, officers, directors and agents of Sponsor, Administrator, and each of their affiliated companies, subsidiaries, licensees, franchisees, distributors, dealers, sales representatives, their advertising and Sweepstakes agencies, and any and all other companies associated with the Sweepstakes (collectively, the "**Sweepstakes Entities**") and each of their immediate family of any person in any of the preceding categories (including mother, father, sister, brother, daughter, son, spouse, grandmother, grandfather, children or grandchildren), regardless of where they live; or persons who reside in the same household, whether related or not, as any person in any of the preceding categories. "Household members" shall mean people who share the same residence at least three months a year, whether related or not. 2. SWEEPSTAKES TIMING: The Harvey Building Products Polaris Switchback Pro-S Sweepstakes (the "**Sweepstakes**") will consist of one drawing to award one (1) prize. Entry begins Saturday, January 25, 2020 at 12:00:01 a.m. Eastern Time ("**ET**") and ends at 11:59:59 p.m. ET on Tuesday, March 31, 2020 (the "**Sweepstakes Period**").

A random drawing will be conducted on or about Thursday, April 9, 2020 by the Administrator, from all eligible entries received during the Sweepstakes Period.

Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Harvey Building Products, 1400 Main Street, Waltham, MA 02451 (the "**Sponsor**") and/or Cohen-Friedberg Associates, LLC, Framingham, MA 01702 www.cfapromo.com (the "**Administrator**") whose decisions shall be final and legally binding in all respects and not subject to further review in any forum.

3. HOW TO ENTER:

- For each \$500 you spend at a local Branch on Harvey Building Products MFG windows and doors, you will receive one (1) entry into the Sweepstakes.

LIMIT: One (1) entry per \$500 spent on Harvey Building Products MFG windows and doors with a limit of twenty (20) maximum entries.

You may enter without a purchase by sending a sending a 3”X5” card in a #10 standard envelope, containing your first name, last name, company name, address, city, state, zip, telephone number, and the local address of the nearest Harvey Building Products Branch to: Harvey Building Products Promotions Department, 1400 Main St, Waltham MA 02451. Mail-in entries must be received inside of the Sweepstakes period. Sponsor is not responsible for lost, late, damaged, incomplete or postage due mail. Limit: 20 entries per person.

Entry Notes: Any attempted form of entry other than as described herein is void. Sponsor will determine in its sole discretion, what constitutes a valid entry and reserves the right to reject any submissions that it deems, in its sole discretion, to violate any of Sponsor’s policies, standards, or practices.

Sponsor reserves the right to cancel or modify the Sweepstakes if fraud or technical failures impair the integrity of the Sweepstakes as determined by the Sponsor, in its sole discretion, and to award the Prize based on eligible entries received prior to the cancellation.

One (1) Grand Prize: Polaris Switchback® Pro-S (model numbers and engines may vary based on manufacturer changes) and **Mission® 10’ Open/Tilt Trailer**. ARV of this prize package is \$14,199.

Prize values are approximations. Any difference between the approximate value and the actual cost of the Prize will not be awarded. Vehicles pictured in any advertising surrounding the Sweepstakes may not be the actual vehicle awarded and is for representation only. Grand Prize winner is responsible for presenting a valid U.S. driver's license, proof of automobile insurance, proof of vehicle registration and paying all sales taxes and other transaction fees or costs imposed on transfer of the vehicle prior to vehicle and trailer delivery. If the prize or the prize notification is returned as undeliverable or any non-compliance with the Official Rules or failure to respond within the applicable time period, it will result in forfeiture of the prize and will be awarded via a random drawing from all remaining eligible entries.
